DIFFERENCE BETWEEN GMP AND NON-GXP SERVICE

Non-GxP / Standard

- Fast processing of orders
- Use of validated, matrix-specific methods are optional.
- No quality agreement required.
- No OOX investigation available.
- Retest service available (to be charged if results are confirmed, otherwise retest fee is waived)
- In-house methods used for analysis.
- Minimal method development performed for new matrices unless otherwise requested.

GMP

- Necessary for batch release or pharmaceuticals.
- Quality agreement in place.
- Extensive method development.
- We recommend doing a matrix specific validation study beforehand.
- For quantification we recommend a minimum of duplicate analysis
- For qualitative analysis we recommend analysis against a standard (i.e., USP Heparin)
- OOX investigation performed (report and analysis surcharge).
- QA review of results.
- Administration surcharge of 30%.
